

## **REPORT: MISSISSIPPI RIVER NETWORK'S RIVER DAYS OF ACTION 2021**

More than 2,500 people participated in the Mississippi River Network's (MRN) River Days of Action June 10-20<sup>th</sup>, 2021! There was something for everybody as 59 MRN members and community partners hosted over 40 in-person and virtual events from hands-on restoration projects to virtual environmental justice panels.

From Headwaters to Gulf and across the basin, 'River Days' was a shining example of what's possible when we act as 1 *Mississippi*. Together, we set a new MRN record by gathering over 5,000 signatures in 10 days on the public petition calling for restoration, resilience, and equity on our Mississippi River.

Numbers are an important part of this story, but not the whole story. Keep reading for uplifting River Days successes and hear from the people who made it possible.

The National Caucus of Environmental Legislators hosted a covid conscious 3-day river tour in Chicago, St. Louis, and Des Moines. Legislators from various river states participated and learned about nutrient pollution reduction, environmental justice, natural infrastructure to reduce flooding and pollution runoff, and healthy soils.
